75. TO RECEIVE A VERBAL UPDATE ON 93 BUS RIDE COMPLETED BY THE TRANSPORT WORKING GROUP

Councillor Lawton reported that the bus outing was very interesting; there were 3 points to mention.

- Firstly, that members were surprised about the extend of the route, that it covers many areas of Biddulph.
- Secondly, that in some areas there are not many bus stops, however, D&G
 operate a hail and ride scheme; the public may not be aware of this, so this
 could be publicised more.
- Lastly, it was a perfect opportunity to proudly show off Biddulph's two new formal bus stops.

Councillor Jones gave thanks to the Chief Officer for organising the trip, and Councillor Harper extended his thanks to Councillor Lawton.
