### **44. TO CONSIDER A RESPONSE IN RELATION TO A SIGNIFICANT NUMBER OF COMPLAINTS OF ANTI-SOCIAL BEHAVIOUR AROUND DOG WALKING AT THE BURIAL GROUNDS AND THE PERSISTENT REMOVAL AND DESTRUCTION OF SIGNAGE**

The Chief Officer noted that there is signage displayed at the burial grounds advising people that it is not an appropriate place for dog walking. There had recently been another complaint from a member of the public; people with dogs off leads is causing significant distress.

The Chief Officer also noted that signage is being removed. There has also recently been a rat problem; it was not clear whether this was exacerbated by dogs, but there may be a risk to animals as a result of the treatment for rats.

Councillor Jones wondered whether tamper-proof crews may be necessary. The Chief Officer had wondered about the creation of a byelaw. Councillor Jackson felt this was worth investigating.

Councillor Hawley suggested that the Staffordshire Moorlands dog warden could include the site in their schedule.

The Chief Officer would investigate more robust signage.

### **45. IN ADVANCE OF BUDGET SETTING, TO CONSIDER PRIORITIES FOR THIS COMMITTEE FOR 2025/26**

The Chief Officer explained that the Committee's priorities should be discussed in advance of the budget setting. This could include the tendering of the lengthsman contract, or the development of the new Garden of Remembrance, or the future of the Butterfly Garden.

It was agreed to add the Butterfly Garden to a future agenda.

Councillor Parkes requested a detailed list of jobs that the lengthsman completes, in advance of tendering opportunities.

#### **46. JOBS FOR LENGTHSMAN (STANDING AGENDA ITEM)**

Councillor Jones reported that the telephone box which houses the defibrillator at Biddulph Park is not in a good condition and requested whether the Town Council could tidy it up. The Chief Officer would seek a quotation for this work.

Councillor Kisicki reported that the layby by Whittemore is overgrown. He also reported that along Tunstall Road (below New Buildings) is overgrown.
