### **67.14 PUBLIC PARTICIPATION**

- a Presentation of the original Chamber of Trade and Commerce (CoTC) Chain of Office to the Town Council for safekeeping by Councillor Gibson:

Councillor Gibson presented the Chain of Office to the Mayor and gave a brief speech on the CoTC, which had been formed in 1958 and was replaced in 2007 by the Biddulph Business Chamber (BBC). The ceramic emblem had been designed by Mr Simpson of Biddulph and may have been made at the Josiah Wedgwood factory at Barlaston.

Councillor Jackson noted that input from both BCoT and BBC had proved invaluable over the years. He gave examples of times of friction, adding that there had always been constructive criticism. Councillor Jackson had enjoyed the Chamber's input to the Regeneration Executive.

Councillor Sheldon paid tribute to Councillor Gibson for all the years he had tried to nurture CoTC and praised him for the way he had stuck to the task and tried his very best for the people and town of Biddulph.

Councillor Hart thanked Councillor Gibson for giving the Chain to the town, adding that Councillor Gibson had served the town for many years, especially noting his invaluable support for the Area Action Plan.

Councillor Hall added his thanks, especially for bringing the Chain to the Town Hall. Councillor Hall felt that it was the right place for it. The Council was now gathering quite an historical collection, which would need to be reorganised so that people could see our heritage.

Councillor Rogers added that Councillor Gibson had put his heart and soul into the job, and had not always received the support he deserved. In the early days the CoTC had been very well attended, but interest had died away. Councillor Rogers hoped that in the future this would change - with an new Chamber, new Chain and new Chair.

The Mayor proposed a vote of thanks to Councillor Gibson, seconded by Councillor Jackson; this was unanimous.

- b PCSO Sherratt reported from an email received from the Chief Constable about Operation Nemesis, where drugs to the value of £15 million and £3 million had been seized and arrests made. A Biddulph Officer had been involved.

The Police and Crime Commissioner (PCC ) Matthew Ellis had been in Biddulph the previous week at both The Roaches and James Bateman Junior High School

Speedwatch had recruited 4 new volunteers.

Vicky Ellis and Moorlands Together had compiled and printed a contact card with phone numbers of emergency and other useful services. Copies were distributed to members.

Sgt Slinn spoke of the Commissioner's People Power Fund; the fund empowers local community groups to find solutions to community safety problems through smaller grants of between £100 and £3000. These could range from the provision of positive activities for young people with the aim of reducing ASB in a local community. Applications can be made via the PCC website or by telephoning 01785 232385, between 1 March and 14 April 2015. The scheme was funded by money seized from criminals and had to be reinvested into local communities. Local police would help with applications.

A local man had been in breach of an ASB order had been sent to court. Another local, who had been intimidating a witness, had been remanded in custody; these were both thought to be good results.

The Mercian Regiment would be in Leek the following day to parade and to host a recruitment drive.

Councillor Jackson asked if there was a ceiling on money gained from the proceeds of crime and who decided which good cause would be helped. Sgt Slinn replied that he was not sure who made the decision, but thought that it was probably a committee in the PCC office. However he did know that from the amount seized 100% would be invested back into the community.
