The Chief Officer introduced the Town Mayor and Deputy Mayor. The Mayor invited Pastor Amy Wyatt to lead members in a time of prayer. The Mayor opened the meeting.

71.15 PUBLIC PARTICIPATION

- a Mr Jackson was invited to address the meeting. He spoke about problems on the Church Road Playing Fields football pitch, with dog fouling and broken glass. He mentioned that a local resident had been seen drinking from bottles and throwing them onto the fields. The football teams had to clear the pitch before every game. Mr Jackson asked for advice on further action. Councillor Salt thanked Mr Jackson for attending and hoped that one result would be that the problem would be reported in the local press. Councillor Jones felt that it was two separate problems and advised that SMDC is contacted about the dog fouling and Staffordshire Police about the anti-social behaviour. Councillor Hart concurred adding that if the bottle thrower was a Moorlands Housing tenant that avenue could be explored. Councillor Jackson – no relation – was pushing for a change in the rules that would mean dog walkers must carry poop bags or face prosecution. Councillor Hall proposed that the information about dog fouling is passed to SMDC as the owner and lessee of the land. Councillor Sheldon advised that a diary of evidence was compiled with photographs if possible which would support a prosecution. Councillor Rogers noted that a referee was responsible for both the players and spectators and should ensure that litter is not left after a match.

- c PCSO's report: PCSO Sherratt was unable to attend, but had left some Staffordshire Smart Alert cards to be circulated. These had also been given to the Youth Advisors that afternoon.

Difficulties with buses to Biddulph Moor were also mentioned; this sometimes resulted in siblings being separated and travelling apart.
